The process for ESSER III included interactions with community/families, school and district administrators, special education administrators, certificated teachers, students, classified staff including paraeducators, and parent groups including the DELAC. The bargaining group (Certificated and Classified) was consulted as part of the plan development process. Specifically for these funds, the district reviewed

funding and sought feedback on needs related to the specific challenges of the COVID pandemic as it relates to safe on-campus instruction and addressing the learning loss that is occurring because of it. A survey document was distributed to all teachers, staff, and parents on September 13, 2021.

Additionally all plans developed and approved by the board are done at a public hearing where all groups are invited to provide feedback to Maricopa.

The school district has recently completed the LCAP plan for 2021-2024. Additionally, a survey was sent to all parents, students (K-8 Leadership and students in grades 9-12), teachers, and staff on September 13, 2021. Over 97 stakeholders responded. A Student survey was given at the end of 7th period on September 17, 2021 to promote student engagement. 59 students (62% of High School population) participated.

#### A description of how the development of the plan was influenced by community input.

Stakeholders were asked if the following were Not Important, Important, or Very Important. The results were:

Parent community survey: 97 total responses. 52.58% parents, 21.65% classified staff, 17.53% certificated staff, 8.24% students. 83% - Ensure high quality education for the students, 77% Additional support of special programs, 67% Social Emotional learning support, 62% Additional High School Programs, 43% Increase Family Engagement.

High School Student survey: 59 total responses (62% of population) 2% wanted facilities improvement, 96.6% believed their educational needs were being met. Students listed the nutrition program, Programs, after school sports, clubs, and science as areas to add to or improve upon.

The district 2021-2024 LCAP Stakeholder Engagement was recently completed as part of the newly adopted LCAP. This plan is referenced as part of this ESSER III expenditure plan. The Stakeholder Engagement feedback is found on pages 10-15. This plan relies upon the feedback within the LCAP as well as the feedback referenced in this description.

As a small school district the input received from the employment and parent groups directly impacted the development of the plan. As well, this feedback validated that the LCAP plan just approved was relevant to the needs and was highly considered while creating this plan.

Due to the responses, we set the priorities as follows:

- Improved facilities for educational programs to be housed
- Increased classroom technology for current and relevant educational offerings
- Increased programs
- Increased student activities
- Field Trips

Improved nutrition programs  
Transportation capacity for increased field trips, programs, and after school sports

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

## Fiscal Requirements

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
